

# North Carolina Stroke Association

Grant applications are now being accepted for  
Stroke Identification and Prevention Projects

*The mission of the North Carolina Stroke Association is to reduce the incidence and impact of stroke through screening and education*

The NCSA is currently offering grants for projects utilizing the Association's Stroke Identification & Prevention Screening tool in areas of North Carolina that this service would not otherwise be available to medically underserved populations of North Carolina.

## STATEMENT OF NEED:

A needs assessment of the county/counties has been determined that there is a significant need for:

- Projects focusing on stroke prevention, screening, and education
- Projects focusing on stroke screening services among minority, uninsured, and underinsured populations
- Projects focusing on medically underserved areas

Funding priority will be given to those projects that specifically address these needs.

## QUALIFICATIONS:

Applications are accepted from North Carolina (501 C3) non-profit institutions.

**RESTRICTIONS:**

- Project must be specific to stroke identification and prevention
- Applicants must be a North Carolina non-profit (federally tax-exempt) organization, e.g. nonprofit organizations, educational institutions, and government agencies
- Grant money is intended for direct costs of the program

**REVIEW:**

Applications received complete, and meeting compliance guidelines, will be submitted for a blinded grant review by a panel established through the North Carolina Stroke Association. Review will be complete within 90 days of receiving the grant.

**EDUCATIONAL MATERIALS:**

A variety of education materials are available from the Stroke Association. Some items are targeted to special populations. Before requesting funds to purchase items from other sources or create new materials, please contact the NCSA. We recommend that Stroke Association materials be used in the project.

**CONTRACTS:**

A grant contract will be the legal mechanism for funding.

**GRANT PERIOD:**

Grant period begins \_\_\_\_\_ and will conclude \_\_\_\_\_ (1 year)

**PAYMENT/REPORTING:**

The payment will be made no later than (30) days after the receipt of the fully executed contract. A final report of the project will be due within (60) days of completion of the grant period.

Application should include and be ordered as follows:

**A. Cover page (Form Attached)**

Note: Signature of approving institutional personnel President/CEO, other than project director, required.

**B. Project description**

1. Brief explanation of project
2. Statement of need/problem to be addressed
3. Description of the population to be served
4. Description of program goals and measurable objectives
5. Description of how these goals are to be accomplished
6. Timetable for accomplishing goals
7. Description of other organizations/entities, if any, participating in the program. If applicable, letters of collaboration should be included from each organization
8. Use of the programs results and how they are to be disseminated to improve quality of care

**C. Financial Information**

1. Budget for requested funds (form attached)
2. List of other sources of funding for the project (include in-kind funding)

**D. Bio-sketch form for project director and attendant personnel listed in budget request.**

**E. Proof of non-profit status for applicant institution**
